WHEREAS, the Charlotte County Board of Supervisors would like to honor Curtis W. Tharpe's entrepreneurial spirit and his contributions to economic development in Charlotte County; and

WHEREAS, the Virginia Department of Transportation completed a new bridge over Roanoke Creek on Virginia Scenic Byway 47 in December of 2013; and

WHEREAS, Roanoke Creek and the new Roanoke Creek Bridge are situated adjacent to Curtis W. Tharpe's family home and his adjoining property,

NOW THEREFORE, BE IT RESOLVED, that the Charlotte County Board of Supervisors does hereby request that the Commonwealth Transportation Board name the bridge on Virginia Scenic Byway 47 over Roanoke Creek as the "Curtis W. Tharpe Bridge."

BE IT FURTHER RESOLVED, that this resolution be permanently recorded in the minutes of the Charlotte County Board of Supervisors.

Representatives from each county joined forces with the Virginia Tourism Corporation, the Virginia Division of State Parks and the National Park Service to design a regional approach and,

WHEREAS, Out of this collaboration came Virginia's Retreat and the development of the Lee's Retreat trail and the Civil Rights in Education Heritage Trail® and,

WHEREAS, Since 2000, Brunswick, Charlotte, Halifax, Lunenburg and Mecklenburg counties have joined this regional approach and,

WHEREAS, The Virginia's Retreat region of South Central Virginia offers travelers meaningful historical attractions and abundant outdoor recreation, boasting the nation's first Civil War History Trail, the Lee's Retreat driving tour and Wilson-Kautz Raid Civil War driving tours, as well as the stirring Civil Rights in Education Heritage Trail® and,

WHEREAS, The mission of Virginia's Retreat is to market the recreational, historical, natural and scenic assets of the region and,

WHEREAS, Virginia's Retreat has been successful for the past five years in obtaining matching Virginia Tourism Leveraging Marketing Grants to obtain a higher return on the investment of the member counties and City of Petersburg and,

WHEREAS, The Virginia's Retreat board of directors recently completed a two year strategic planning process funded by the Virginia Tobacco Commission and,

WHEREAS, One of the recommendations of the strategic plan was that the Board of Virginia's Retreat should apply for nonprofit designation in order to fundraise, receive corporate donations, apply for more grant opportunities to increase to a higher level the return on investment so that Virginia's Retreat can increase the marketing activity for the region,

NOW, THEREFORE, BE IT RESOLVED that the Charlotte County Board of Supervisors fully supports the request from the Board of Virginia's Retreat to apply for nonprofit designation.
